

DETAILS: On date and time listed, Sergeant Jones and I were dispatched to a disturbance call at Café Boogaloo (1238 Hermosa Avenue). A described male subject was swinging around a "statue" trying to hit people with it, and location security was holding him down trying to prevent this. Upon arrival, I observed S/1 face down on the sidewalk in front of the location with location security employees holding him down. S/1 was screaming and kicking. For safety, I handcuffed S/1 and walked him out of the crowd that had gathered around him. I noted there were minor scratches on his cheeks and forehead likely caused by the struggle he had with location security. While S/1 was detained and seated on a nearby curb (handcuffed), S/1 retrieved a cellular phone from his right front pants pocket and started to manipulate it (possibly dialing, unknown for sure). Not knowing if he was telephoning for help from a friend, retrieving a weapon (see knife/phone and gun/phone training bulletins), or trying to destroy evidence, I attempted to take the cellular phone from his hand. He screamed "Fuck you Faggot!" and proceeded to cling to the phone in his hand in a "death grip", refusing to relinquish the phone. I repeatedly ordered him to give me the phone, he would respond, "No!" and scream wildly. Ultimately with Sergeant Jones assistance, and me applying my thumb to his mandible pressure point as a distraction, we were able to take the phone from S/1. Moments later, S/1 attempted to stand up, and we had to push him back to a seated position on the curb. I noted the strong odor of alcohol coming from his breath, his speech was loud and slurred, and his demeanor was belligerent uncooperative and combative. (see Higgins audio download)

Sergeant Jones spoke with W/Harrison, who is location security at Café Boogaloo. He said that S/1 began to start a disturbance inside the location. Location security physically had to remove S/1 out the front door. Once outside, S/1 became enraged and picked up a heavy line marker/line post and began to swing it wildly at employees and pedestrians. S/1 continually spit on location security and pedestrians. Location security wrestled the marker/line post from S/1 and held him on the ground until police arrived.

I spoke with W/Bartz who told me essentially the same thing as W/Harrison.

If S/1 had successfully struck somebody with the marker/line post, he would have surely injured them based on the marker/line posts weight and size.

We could not find anyone injured or interested in prosecution. Based on his physical objective symptoms and his belligerent behavior, I arrested S/1 for 647(f) PC.

Officer Garcia responded to transport S/1. After we had to force S/1 into the police car (S/1 refused to get all the way into the car), S/1 was transported to the HBPD jail by Officer Garcia. S/1 was so belligerent and uncooperative at the HBPD jail; he was immediately placed in the detoxification cell and not booked until approximately 0800HRS once he had become more sober. During his stay in the detoxification cell, S/1 vomited on the floor (see jail video).

Sergeant Jones right knee had a minor bleeding cut and a hole in his uniform pant leg as a result of the struggle with S/1's for his cellular telephone detailed above.
