Source: On 3-20-04 at approx. 2355 hours, Officer Saylor and I (Sellan) conducted a bar check at the Lighthouse Bar (30 Pier Ave). During our check we observed numerous patrons on the patio and we were unable to walk through the area without physically pushing our way through. Once inside the bar we experienced the same problem. We determined that the situation was hazardous so we notified the Hermosa Beach Fire Department.

Investigation: HBFD responded to the Lighthouse Bar and Captain Garofano and his crew conducted an occupancy load check. After his check was conducted he advised me that the bar was in a hazard condition and overcrowded.

Arrest: Based on the above information, we cited the on duty bar manager Theresa Falcone for 103.4.4 UFC / 15.20.010 HBMC (maintaining hazardous conditions) and 2501.16.3 UFC (over crowding). Falcone signed the citation in our presence.
