Source: On 3-28-04 at approx. 0025 hours, Officer Saylor, Assistant Fire Chief Gomez, and I (Sellan) conducted a bar check of 705 nightclub.

Observations / Investigation: As we were entering the bar Chief Gomez asked the doorman what his count was and the doorman stated, "Seven hundred and ninety." After we walked through the bar, Chief Gomez requested fire personnel to come to our location and conduct a life safety occupancy check. Captain Crawford (HBFD) and other fire personnel arrived and conducted their occupancy check (see HBFD's report).

Arrest: Once the firemen were done with their occupancy check, Chief Gomez advised me that the bar was over their maximum occupant capacity. Chief Gomez then directed me to issue the owner Grace M. Roberts a citation for 103.4.4 UFC / 15.20.010 (maintaining a hazardous condition) and 2501.16.3 UFC (over crowded). I issued Roberts a citation for the above violations and she signed the citation in my presence.

Additional: While fire personnel were conducting the occupancy check inside the bar approx. 124 people exited the bar.
