On 07-02-2005 at approx. 11:55am personnel from E11, and A12 arrived at The Lighthouse, 30 Pier Ave., Hermosa Beach CA in a response to a police request for an occupancy check.

Summary

On arrival I observed the interior of the establishment appeared to be over occupancy load limits. I instructed fire department personnel to enter the business and give me three (3) separate head counts using mechanical counters. Resulting in an average count of 210. The current occupant load is 135 on the interior and 26 on the patio.

I found them in violation of Section 2501.16.3 of the uniform fire code. Overcrowding and admittance of people beyond the approved capacity of a place of assembly is prohibited.

Interior Inspection

Upon inspection the establishment had a high concentration of people in one area. Free movement was not impeded, with aisles and means of egress were mostly unobstructed.

Issuance of the Citation

Theresa Falcone who identified herself as the manager was notified that the establishment was being cited. Ms. Falcone accepted the citation and apologized for the inconvenience. Ms. Falcone also reduced the occupancy numbers within the posted occupancy load during the time it took to complete the citation.
