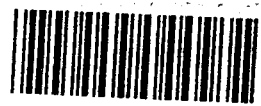

On 07-03-2005 at approx. 12:30am personnel from E11, and A12 arrived at Blue 32, 1332 Hermosa Ave., Hermosa Beach CA in a response to a police request for an occupancy check.

### Summary

On arrival I observed the interior of the establishment appeared to be over occupancy load limits. I instructed fire department personnel to enter the business and give me three (3) separate head counts on the interior using mechanical counters. Resulting in an average count of 130. The current occupant load is 91. The establishment did have a posted occupancy load certification of 91 that was not hanging in a visible location. I found them in violation of Section 2501.16.3 of the uniform fire code. Overcrowding and admittance of people beyond the approved capacity of a place of assembly is prohibited.

### Interior Inspection

Upon inspection the establishment had a high concentration of people in one area. Free movement was not impeded, with aisles and means of egress were mostly unobstructed.

### Issuance of the Citation

Nick Klutka who identified himself as an owner was notified that the establishment was being cited. Mr. Klutka accepted the citation and apologized for the inconvenience. Mr. Klutka also reduced the occupancy numbers within the posted

occupancy load during the time it took to complete the citation and promised to hang the certification appropriately.
