

Report on overcrowding:

On June 19, 2005 at 12:10 am while doing city wide occupancy checks as mandated by the fire chief we found Blue 32, a nightclub located at 1332 Hermosa Ave. in Hermosa Beach, to be in excess of their posted occupancy rating. Their posted occupancy is 91. We counted the occupancy using hand clicked type counters multiple times to assure the business that they were getting an accurate count. The last time we counted we went through the business with the owner and he was satisfied the count was accurate. We had a count of 158 and 153 on our two counters. We cited Mike Lowe who identified himself as a part owner. During the citation process the establishment reduced their numbers to an acceptable level.
