

# Hermosa Beach Fire Department

## Report on overcrowding:

On June 19, 2005 at 12:40 am while doing city wide occupancy checks as mandated by the fire chief we found the North End, a nightclub located at 2626 Hermosa Ave., Hermosa Beach, to be in excess of their posted occupancy rating. Their posted occupancy is 80. We counted the occupancy using hand clicked type counters. We had a count of 123 and 125 on our two counters. We cited Thomas Muldowney who identified himself as a manager. During the citation process the establishment reduced their numbers to an acceptable level.
