

# Second suspect in home attack arrested, two remain at large

The Manhattan Beach Police made one more arrest in a brutal home invasion robbery, leaving two of the four suspects still at large.

A Manhattan Beach couple who had spent the evening at several bars in Hermosa

Beach were followed home and then attacked by four suspects, two men and two women, in a home invasion-style robbery on March 2. The victims had spent much of the night with the two female suspects and on March 13, police released two photos of the women that were

taken at one of the bars to the media.

It was the media coverage that prompted one of the suspects, Edna Decembra Monrreal, 27, to turn herself in.

After calling Manhattan Beach police several times, Monrreal arrived at the temporary Peck Avenue Manhattan Beach Police station on March 16 accompanied by several family members and turned herself in, Capt. Randy Leaf said at the time of the arrest.

Subsequent to the arrest of Monrreal, detectives developed information on two additional suspects and on March 22, police arrested Rolland Wormely, 31, of Bellflower, on a state parole violation. The District Attorney charged Wormely with two counts each of attempted murder, robbery and assault with a deadly weapon. The other female suspect has been identified as Tamiaka Eleby, 26, of Compton, and has also been charged with two counts of attempted murder, robbery and assault with a deadly weapon. Detectives are currently attempting to locate and arrest Eleby in connection with the crime, stated Manhattan Beach Police Sgt. Steve Tobias in a press release.

Another unidentified male suspect also remains at large.

After the suspects fled the crime scene, Manhattan Beach Police received an emergency phone call from one of the victims at about 5:10 a.m. on March 2.

When police arrived at the scene, a home in the 600 block of Valley Drive, they found 54-year-old Kevin Scannell, an actor, and a 43-year-old female, both of

whom were the victims of severe beatings by a golf club and other blunt force objects.

Both Scannell and the female victim were taken to Harbor-UCLA Medical Center by paramedics. They were released approximately 24 hours later.

According to Manhattan Beach Police investigations reveal that after spending some time at Blue 32 in Hermosa Beach, the couple returned home at about 2:15 a.m. Prior to being at the club, the couple was at another local club.

After being home for a period of time, two suspects described by the victims as male African American adults entered the residence wearing "some type of face covering" and committed a robbery, Tobias said.

The two men knew the female suspects and police "believe that the women the victims met at the bar facilitated this crime," stated a press release.

The four suspects beat the victims with a golf club and other blunt force objects, inflicting numerous cuts and contusions. The suspects then stole multiple items such as personal electronics, a computer and cash, reported authorities.

Scannell has appeared in many television shows and movies over the years, such as "Operation Delta Force 3: Clear Target" and "Bowfinger," and television appearances on such shows as "Beverly Hills 90210" and "Home Improvement."

The Manhattan Beach Police are continuing to investigate this crime and anyone with information is asked to contact police at 802-5140.
