**Synopsis:** Unknown Suspects use bodily force to take cellular phone from Victim with negative results.

**Source:** On 7-21-06 at approximately 0225 hours, I responded to [REDACTED] regarding a 211 report. Upon arrival, I contacted Victim [REDACTED] who stated essentially the following.

**Details:** On 7-21-06 at approximately 0145 hours, Victim [REDACTED] stated that he was walking home and talking on his cellular phone. [REDACTED] was walking E/B 8<sup>th</sup> street near the intersection at Bayview Drive when two male suspects (NFI, NFD) attacked him from behind. [REDACTED] added that he avoided one suspect and the other one punched him in the head and was yelling, "gimme your cell phone". Fearing for his safety, [REDACTED] was able to run on foot away from the scene. He then ran N/B Bayview and heard a loud, "Bang". [REDACTED] was unsure if it was a gun shot and did not know what the noise was.

Victim [REDACTED] could not describe either suspect or their clothing, but was positive that they were males due to their voices. No property was taken from [REDACTED] however he is desirous of prosecution if suspects are located.

Note: I examined the area at the intersection of 8<sup>th</sup> st/Bayview with negative results for any evidence of the suspects or gunfire. No other reports of shots fired were received via dispatch.

On 07/21/06 at appx. 0620 hrs I spoke with the reporting party. He states that at appx. 0100 to 0130 hrs he was asleep in his home when he heard a loud "crack". In the morning he discovered a bullet hole in the second story south facing window of his home.

I observed a bullet hole in the double pane south window on the second floor south side of the victims' residence. This was the window nearest to the east side of the house.

The interior wood slat blinds for the window also had a bullet hole in them. Directly across the room from the window I could see where a bullet had gone through a closet door, passing between the door and the jab and leaving the edges of them abraded.

Inside the closet an impact mark could be seen on an item of clothing. The clothing was not torn. Directly below this I found a spent copper-jacketed bullet.

At the time he heard the noise the home was occupied by the R/P, his wife, his

Sgt. Thompson responded to the scene and took digital photographs of the location. Sgt. Thompson and I carefully searched Bayview Drive leading south from the victim residence for any spent casings and found none.

I noted the farthest south 'Line of sight' to the victim location is at the west property line of [REDACTED] Bayview Drive.

I logged the spent bullet into evidence.
