On 08-13-2006 at approx. 1700 hrs. personnel from E11 Fire Marshall Osekowsky, Eng. De Los Santos and I arrived at Dragon, 22 Pier Ave., Hermosa Beach CA, for an occupancy check.

Summary

On arrival I observed the patio of the establishment appeared to be over the occupancy load limits. I instructed fire department personnel to give me two (2) separate head counts on the patio and interior using mechanical counters. Resulting in an average count of 60 on the patio. Osekowsky 62 and De Los Santos 58 were their counts, at approx. 1700 hrs. The Fire Marshal took another count at approx. 1710 hrs. and counted 61. The current occupant load is 46 for the patio.

Further inspection revealed that the interior of the establishment was also over occupancy using mechanical counters De Los Santos counted from front to back 54 patio and 230 interior for a total of 284, Osekowsky counted front to back 61 patio 220 interior for a total of 281. The total occupancy for that business is 204 inside and 46 outside for a total of 250.

Violations

Section 2501.16.3 of the uniform fire code.
Overcrowding and admittance of people beyond the approved capacity of a place of assembly is prohibited.
