**Synopsis:** On 9/22/06 at approximately 2358 hours, the victim and suspect got into a physical altercation inside Blue 32, located 1332 Hermosa Avenue. During the altercation the suspect bit the victim's left hand causing a moderate laceration (human bite). The victim was transported to LCM and the suspect was arrested per Private Persons Arrest (Ref. Arrest Report).

**Details:** On 9/22/06 at approximately 2358 hours, my partner (Ofc. Ramirez) and I responded to Blue 32 located at 1332 Hermosa Avenue on an unknown disturbance occurring in front of the establishment.

Upon arrival, I was contacted by a female later identified as [REDACTED] G [REDACTED] who stated the following: G [REDACTED] related while she was dancing with a male friend ([REDACTED] H [REDACTED]), an unknown female (later identified as [REDACTED] Casillas) approached her on the dance floor and bit her hand causing bleeding (Human bite). A physical altercation occurred and G [REDACTED] in defense pulled the suspects hair. Blue 32 staff separated the two subjects and escorted them out of the bar. While talking with G [REDACTED], she pointed to Casillas who was standing approximately five feet away stating "That's the bitch that bit me"; "I want her in jail". Prior to my arrival, G [REDACTED] learned that the male subject she was dancing with was the ex-boyfriend of Casillas.

I made contact with [REDACTED] H [REDACTED] who related the following: While he was dancing with G [REDACTED], Casillas (His Ex-girlfriend) came over to G [REDACTED] and they got into a verbal argument. During the argument they started to physically fight pulling each others hair and scratching each other. At one point while G [REDACTED] was pulling on Casillas' hair, H [REDACTED] observed Casillas bite G [REDACTED]'s hand in attempt to have her let go of her hair.

I made contact with [REDACTED] K [REDACTED] who related the following: When K [REDACTED] came out of the restroom she observed her friend G [REDACTED] and Casillas in a physical fight on the dance-floor. She observed Casillas biting G [REDACTED]'s hand and pulling her hair. K [REDACTED] in attempt to pull Casillas off of G [REDACTED] K [REDACTED] pulled on the back of G [REDACTED]'s hair before being separated by Blue 32 staff.

G [REDACTED] was treated by HBFD Paramedics for a +/- 1 1/2" open human bite mark and transported to LCM Hospital for further medical evaluation.

G [REDACTED] is desirous of prosecution and signed a Private Persons Arrest Form in my presence. Note G [REDACTED] will be out of the county for two month as of 9/25/06. She advised me that she would make herself available for any further investigation and the courts.

I examined the surveillance video from Blue 32, with negative results. The angle of the cameras did not capture the incident.

**Arrest:** On 9-2-06 at 0015 hours, I arrested [REDACTED] Casillas for Public Intoxication and Battery per a Private Persons Arrest. Casillas was transported and booked in the HBPD.

On 9-21-06 at 2358 hours, Ofc. Brunn and I were conducting a security check of the parking structure (1301 Hermosa Ave.) when we observed a disturbance at Blue 32 (1332 Hermosa Ave.) As we arrived we contacted a female subject, [REDACTED] G [REDACTED], who stated a female later identified as [REDACTED] Casillas assaulted her. Ofc. Brunn received further statements from G [REDACTED] (see crime report). I then contacted Casillas at the front door way of Blue 32. Casillas stated the following:

Casillas said she was at Blue 32 with several friends and a man she is dating, when she observed an ex-boyfriend [REDACTED] H [REDACTED]. Casillas said she noticed he was dancing with a female subject (G [REDACTED]) who she had never seen before. Casillas said that all of a sudden G [REDACTED] pulled her hair and began punching her. Casillas said she defended herself by pulling G [REDACTED]'s hair and punching back. Casillas said that Blue 32 staff then separated them.

I asked Casillas if at any time she bit G [REDACTED] on her hand. Casillas denied ever biting her anywhere and states she was only defending herself.

While talking with Casillas, I observed the following signs and symptoms of intoxication: Casillas had a strong odor of an alcoholic beverage coming from her person, her speech was slurred, mumbled, and she was loud (excited) as she spoke. Casillas eyes were bloodshot, watery, and she was unsteady on her feet, swaying as I talked with her. Based upon all the above, I formed the opinion that Casillas was intoxicated to the point that she was unable to care for her own safety or for the safety of others.

Casillas was arrested for Public Intoxication and added charges of Battery, per a Private Persons Arrest.
