Source: Dispatched to the station regarding battery report

Statement: On 10/09/06 at approximately 1345 hours I was dispatched to the station regarding a battery report. Upon my arrival I contacted Victim G [REDACTED] who reported the following information:

Victim stated on 10/07/06 at approximately 0130 hours he was inside Blue 32 Bar, 1332 Hermosa Avenue with his brother and friends. Victim stated he and his brother were talking to some females prior to the incident. Victim stated minutes later the females again engaged him in conversation asking him to join them on the podium. Victim then jumped onto the podium and began dancing with the females (Unknown names).

While on the podium for approximately two to three minutes he was grabbed from behind by S-1. S-1 grabbed his shirt pulling him down off the podium causing injury to his ankle and knee.

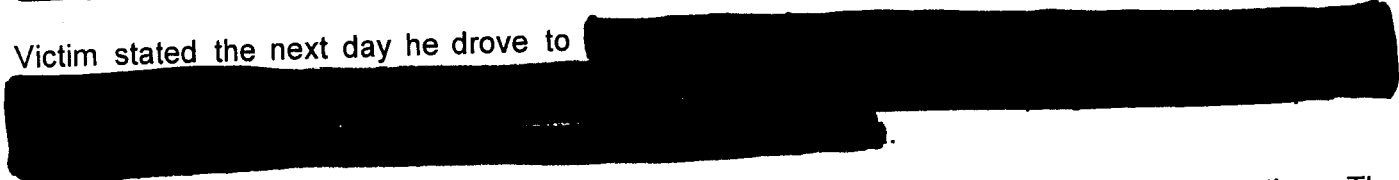
Ten to fifteen seconds later his brother and friends walked up to him asking what happened, who hit you. The victim then pointed at the suspect standing in the corner (Estimated by the victim ten feet to his left) and pointed at him stating "That mother fucker."

S-1 then walked back up to the victim and clenched his right fist striking the victim in the throat. Victim staggered, bent over at the waist and was placed in a head lock. Victim then received approximately twelve blows to the head and face. While still in a head lock victim states three to four unknown males began striking him in the back and ribs. Victim also stated he was dragged from the rear of the bar to the outside hallway of the strip mall. Victim then stated to S-1 "Why are you doing this, why are you doing this." The victim's brother then approached and stated "stop." Several other males approached and instructed victim's brother not gets involved. Victim stated S-1 then released him from the headlock and was pushed away. Victim stated his brother and friends were also wrestled to the ground by unknown males.

Victim stated him along with his brother and friends left the hallway and contacted unknown named Hermosa Beach Police Officers in front of the location. Officers advised victim to just go home. Victim sustained the following injuries:



Victim stated the next day he drove to



Victim stated he could positively identify S-1 if seen again and is desirous pf prosecution. The victim stated he would not be able to identify the other suspects involved. See documentation provided by the victim under the same report number.

While interviewing the victim I did not personally notice any visible injuries. According to the victim's statement at the time of the interview, he indicated that the battery occurred on 10/07/06. However after reading his statement he indicates that it occurred on 10/02/06 (Inconsistent).
