## Narrative

(█████PCH) regarding a theft report. Upon arrival, I contacted store manager ██████ who stated essentially the following.

Details: R/P G█████ stated that he opened the store today at approximately 0845 hours and observed that two cellular telephones were missing from the display rack. G█████ contacted several employees from yesterday's shift (12-16-06) regarding the removal of the phones and none of the employees were aware of the phones missing. G█████ then reviewed the store surveillance tape and observed a male suspect remove the phones from the display rack. He then called HBPD for a report/investigation.

I viewed the surveillance tape from 12-16-06 at approximately 1830 hours and observed the male suspect remove the phones from the display rack. It appeared that the suspect was connected to a group of 3-5 male subjects. Due to the clarity and size of the video I could not determine the race and further descriptors of the subjects. They all appeared to be 20-25 years old wearing baggy clothing and baseball caps. The suspect that removed the phones was possibly a male black or hispanic with a unique hair style with rubber bands throughout.

R/P G█████ added that he will make a copy of the surveillance tape and bring it to the station within a few days. G█████ is desirous of prosecution.

Source of activity: On 12-17-2006, I received a radio call to respond to [REDACTED] at [REDACTED] PCH [REDACTED] regarding a theft that had occurred. On arrival I spoke to the R/P [REDACTED] G [REDACTED] who told me the following;

Statement/ G [REDACTED]: [REDACTED] told me he is the sales manager at the store. He essentially told me that at approximately 1541 hours, a male black subject entered the store to purchase a phone. The subject asked if he could put another phone on another account. The account in question belongs to [REDACTED] F [REDACTED]. The subject claimed to be related to F [REDACTED] some how. The male black subject then went to a display rack and began looking at cell phones. He selected a Cingular 3125 from a wall display and began looking to his right. The subject then removed the security cord attached to the phone and put it in his pocket. The subject then left the store passing several opened and manned registers failing to pay for the phone. The cell phone number to the stolen phone is [REDACTED]

Evidence: G [REDACTED] has a video tape of the incident. He will provide it to the police department sometime next week.

Additional Info: It should also be noted that it appeared that the male black suspect was accompanied by an Asian or Philippine women. The women is described as having long dark
