### Narrative

On 12/20/06 I was dispatched to the station lobby regarding a vehicle burglary. I contacted the victim, S, who related the following: S stated he placed his laptop computer under the front driver's seat of his vehicle on 12/19/06 at approx. 2100 hrs. S then drove to Hermosa Beach and parked and locked his vehicle in the 1300 block of Manhattan Ave. at approx. 2115hrs. S then went to The Shore bar and returned at approx. 2400 hrs. and entered his vehicle with a passenger. S said that he was sure his vehicle was locked when he returned. S drove away from the location and was stopped for a traffic violation by a South Bay DUI task force unit. S was subsequently arrested for DUI and his vehicle was impounded and taken to Frank Scotto Tow on 1750 W. 223rd St. in Torrance.

S recovered his vehicle from Scotto towing on 12/20/06 at approx. 1730hrs. and discovered his laptop was missing from under the front driver's seat.
