Narrative

On 01-01-07 at approximately 0117 hours I responded to Blue 32 reference a 242 P.C. (battery) that just occurred. Upon my arrival the involved parties were already separated and were being interviewed by Officer Faulk. I contacted (V) H [REDACTED] who was standing in the 1300 block of Hermosa Ave and he stated the following: He was walking out of the bar (Blue 32) when he was punched and kicked in the head. Victim H [REDACTED] couldn't recall the details of the incident because he was knocked unconscious after the assault. I asked the victim if he desired medical attention but he declined. I asked the victim questions to see if he was alert and he was. Based on the fact that he was knocked unconscious, HBFD Rescue 11 responded and treated H [REDACTED] at the scene. (V) H [REDACTED] declined any further treatment and signed a medical release form (see attached).

I then contacted (W1 B [REDACTED]) who was standing next to (V) H [REDACTED] during the altercation and he stated the following: He and (V) H [REDACTED] were walking out of the bar when a male black wearing an orange shirt and black hat ran up behind them and with a closed fist struck (V) H [REDACTED] to the left side of the head. H [REDACTED] fell to the ground and (S) [REDACTED] proceeded to kick him in the head 2 times before [REDACTED] ran back into the bar. I asked him if there was any reason for the altercation, and he stated that the suspect had no reason to assault (V) H [REDACTED]. Witness B [REDACTED] did state that before they left the bar there was a verbal altercation between the victim and another patron inside the club, but no physical altercation took place.

I then contacted (W2) K [REDACTED], who is a bouncer at Blue 32, and he stated the following: Victim H [REDACTED] and his friends were getting loud and were asked to leave. He escorted the group out of the bar and saw them walk southbound Hermosa Avenue. He went back inside the bar and did not witness any altercation between the (V) H [REDACTED] and the (S) [REDACTED].

Additional: B [REDACTED] positively identified (S) [REDACTED] as the person who punched and kicked (V) H [REDACTED]. [REDACTED] was wearing an orange shirt and black hat the time of the identification. Based on the victim's injuries and witness statements, [REDACTED] was arrested and booked for the above penal code 245(a)(1).

staff. As they were all leaving the bar a verbal argument ensued. As they were walking south bound on Hermosa Ave a subject described as (suspect 1) a male black adult wearing an orange shirt and the bouncer of the bar pursued them. As they approached 13th street S1 stated to the bouncer since you can't do anything I am. S1 then punched V1 with a closed right fist to his face. V1 then fell to the ground and S1 then kicked V1 to the head two times with his right foot.

As W3 looked towards Blue32 he pointed towards the bar and said, "That's him the guy in the orange shirt". Positively identifying S1.

W4 (D██████) stated essentially the same as W3.
