### Narrative

On 1-6-07 at approximately 2154 hrs. Ofc. Smith #158 and I were flagged down near 13th St. and Hermosa Ave. about a possible assault that had occurred at 50 Pier Ave. We arrived at that location at approximately 2155 hrs. and I contacted the victim, [REDACTED] A. [REDACTED] A. [REDACTED] told me essentially the following: A [REDACTED] said he was working as the front doorman for Fat Face Fenner's Fishshack, when he noticed a male standing at the S/W corner of the building staring him down. A [REDACTED] said suddenly the suspect (described as a MWA, 30's, 600, 180, wearing a plaid brown and white shirt with only the top button buttoned, white T-shirt underneath, blue jeans and black baseball cap) charged/ran at him with a knife in his right hand. A [REDACTED] said the suspect swung the knife at his mid-section. A [REDACTED] said he then backed up as the suspect swung the knife at him again. A [REDACTED] said that he reached back for his flashlight and the suspect said "What" A [REDACTED] said the suspect then ran toward Pier Ave., to N/B Hermosa Ave. before A [REDACTED] lost sight of him.

### Narrative

A [REDACTED] said that he had never seen the suspect before, but could identify him if seen again. A [REDACTED] said he felt like the suspect had come to the location to hurt him. A [REDACTED] said he was in fear of his life during the attack and is afraid the suspect may return.

### INVESTIGATION:

Officers checked the area but met with negative results. A [REDACTED] believed the suspect may have ran past the Beach Market, [REDACTED] Hermosa Ave. The Beach Market does have video camera that may have caught the suspect running past the front of the building. I advised the night clerk, who did not have access to the video equipment, to have the owner save the night's video and that an officer would pick it up in the next day.

### Narrative

Narrative: On 1-6-07 at approximately 2154 hours Officer Jones and I were flagged down of an assault that had just occurred at Fat Face Fenners Fishshack (Pier Ave.). We responded to the location and contacted the victim identified as A. Upon arrival Officer Jones contacted A. and obtained statements (see report, same DR#). I contacted R. who was a witness.

During my contact with R. he related the following: R. works as a doorman at Fat Face Fenners Fishshack. He and A. were standing at the door when they observed a subject standing off in the distance looking in their direction. R. stated, "The guy ran up on us and tried to stab A.". R. added that he was unable to stab A. and proceeded to run back to Pier Ave. and was last seen E/B from the location. It should also be noted that if seen again R. can identify the suspect.
