Narrative

On 1/7/07 at approximately 0259 hours, I was dispatched to [REDACTED] 28th street regarding a possible battery report. Upon arrival I contacted IP1 [REDACTED] S [REDACTED] who stated the following;

IP1 stated that she was at "Blue32", [REDACTED] Hermosa Ave. drinking and partying. She stated that she spent 250 dollars on a table for her and a friend. IP1 stated that at approximately 0215 hours, she was thrown out of "Blue32" and sustained a very small scratch to her left elbow. IP1 keep emphasizing how embarrassed she was about getting thrown out of the bar. I asked IP1 if I could speak with her friend that was with her. IP1 went into her room to get IP2 (Y [REDACTED]) as IP2 walked out of the room both IP1 and IP2 could barely hold themselves up without holding onto the walls and furniture around the house.

I asked IP2 if she was ok and she responded yes "I am just drunk". When I asked IP2 what had happened she could not tell me what had happened. She wanted to tell me how much money she had spent for the table that they had reserved. IP2 could not make complete sentences; her friend had to assist her. I asked IP2 if she had any injuries and she stated that she had no injuries and that she was just upset on how they were treated at the end of the night. I informed IP1 & IP2 that I would document the events in an incident report.

I contacted IP3 [REDACTED] W [REDACTED] at Blue 32; I asked if he remembered two ladies that he had to kick out of his bar. IP3 stated that two ladies were drunk and out of control when the bar was closing. They were asked to leave by IP3 and IP4 [REDACTED] H [REDACTED] and they refused. When IP4 began to escort the two ladies one slapped him on the right side of his face. I asked IP3 if he recalled one of the ladies falling down as they were taken out of the bar. IP3 told me as they
