SOURCE: On 1-7-07 at approximately 1420 hours, I responded to the HBPD lobby regarding a 484PC report. Upon arrival, I contacted Victim [REDACTED] L who stated essentially the following.

DETAILS: Victim L stated that on 12-25-06, she parked and secured her vehicle to the rear of the Pitcher House bar at approximately 2200 hours. L returned to her vehicle at approximately midnight to retrieve money from her wallet. She then left her wallet on the floor board and returned to the bar. L was unsure if she locked her vehicle at this time due to being, "Drunk". L returned to her vehicle again on 12-26-06 at approximately 0530 hours and drove home to her residence in Redondo Beach, Ca. L stated that she searched for her wallet in her vehicle while at her residence at approximately 1200 hours and discovered it missing. L did not report the theft of her wallet at this time and did not observe any forced entry into her vehicle.
