Narrative

On 1-13-07 at 1346 hours I (Droz) #173 was dispatched the HBPD front lobby regarding a 487 PC grand theft report. I contacted the victim, Alexander [REDACTED] and he told me the following.

[REDACTED] said that during the evening of 1-12-07 he went to The Shore Restaurant and Lounge, located at 1320 Hermosa Avenue, to celebrate his birthday. On 1-13-07 at approximately 0145 hours [REDACTED] was leaving this establishment carrying his birthday cake. While walking northbound in the 1300 Block of Hermosa Avenue, he contacted a member of the Los Angeles Lakers basketball team named Ronny [REDACTED] asked [REDACTED] to join him in a photograph. [REDACTED] and [REDACTED] then posed for a photograph with each other. After being photographed, [REDACTED] walked a short distance away and [REDACTED] stood in front of the Blue 32 nightclub which is located at 1332 Hermosa Avenue. While standing in front of Blue 32, [REDACTED] held onto his birthday cake with both of his hands. Another member of the Los Angeles Lakers basketball team, Kwame [REDACTED], then forced [REDACTED] cake out of his hands without his permission. [REDACTED] took possession of this cake and threw it at [REDACTED] the cake hit [REDACTED] upper back area and [REDACTED] proceeded to a nearby Limousine, CA LIC# [REDACTED] which was parked in front of Blue 32. [REDACTED] attempted to confront [REDACTED] but [REDACTED] entered the limousine and was driven away.

[REDACTED] then continued to proceed northbound in the 1300 Block of Hermosa Avenue and observed another member of The Lakers basketball team, Lamar [REDACTED] was exiting Pedone's Pizzeria which is located at 1332 Hermosa Avenue. [REDACTED] confronted [REDACTED] regarding the stolen birthday cake. While talking with [REDACTED] [REDACTED] was pushed into the street by an unknown suspect who was possibly employed as [REDACTED] bodyguard. This suspect

yelled, "Get away from [REDACTED] [REDACTED] then told the suspect, "Calm down, he didn't do anything." [REDACTED] then proceeded to leave the area. He did not sustain any physical injuries from this attack. [REDACTED] described his attacker as an African-American male wearing a light colored jacket, refer to suspect page for additional description.

[REDACTED] described his birthday cake as a single layer chocolate cake which was approximately two feet by two feet wide, and which cost approximately \$190.00 dollars. He is desirous of prosecution against [REDACTED] for stealing his birthday cake and is desirous of prosecution against his unidentified attacker for assaulting him.

It should be noted that several members of the Los Angeles Lakers basketball team, including the above mentioned subjects, had patronized Blue 32 during the hours prior to the above incident. Blue 32 has interior surveillance cameras that could have potentially filmed [REDACTED] unknown attacker.
