Narrative

On 12/15/07 at approximately 0308 hours I responded to a 459 PC - burglary alarm at [REDACTED] Hermosa Ave. I arrived and observed the following.

I observed two subjects crossing Hermosa Ave from the east curb to the west curb. One subject later identified as the victim ([REDACTED]), was following the second subject telling him to stop. [REDACTED] flagged me down and told me that he needed the second subject stopped.

I detained the subject, who was later identified as the suspect Bingham, [REDACTED] DOB: [REDACTED]. I contacted [REDACTED] who told me the following. [REDACTED] was sitting in his truck, which was parked on the east curb of Hermosa Ave. [REDACTED] observed Bingham run from the west curb of Hermosa Ave. towards [REDACTED] truck. Bingham threw his body into the side of [REDACTED] truck, causing a large dent in the driver's side door. Bingham began walking away from [REDACTED] and I arrived moments later. [REDACTED] signed a private person's arrest form, and two misdemeanor complaint forms for 594(a)(2) PC - Vandalism.

While I was speaking to [REDACTED], an unidentified witness stated that prior to Bingham running into [REDACTED] vehicle, he (Bingham) was kicking and throwing his body into nearby taxicabs.

I arrested Bingham on [REDACTED] behalf. Bingham was issued a citation for vandalism and released at the scene.

I photographed the damage done to [REDACTED] vehicle. The photographs were later downloaded into the designated computer at their Hermosa Beach Police Station.
