Narrative

Arrest: On 12/01/07 at approximately 0134 hours, [REDACTED] Baham (DOB [REDACTED]) was arrested from 1st Ct and Monterey Blvd. for DUI, 23152(a) CVC. She was transported and booked into the H.B.P.D., without further incident.

Probable Cause for Stop: On 12/01/07 at approximately 0116 hours, while I was standing next to my marked patrol vehicle S/B Monterey Blvd. (1100 Blk). I observed a purple Saturn (Lic. [REDACTED]) accelerating at an unsafe speed S/B Monterey Blvd. from Pier Avenue. As the vehicle approached my parked patrol vehicle (driving lights on), the Saturn almost collided into

the rear of my vehicle, causing me to jump out of the way in attempt from not getting hit. The vehicle turned/swerved last second around my vehicle and continued S/B Monterey Blvd. As I watched the vehicle, I observed it cross the center dividing line at Monterey Blvd. and 8th Street.

As I attempted to catch up with the vehicle, the driver made an abrupt turn, without signaling onto W/B 4th Street, then onto S/B Manhattan Avenue. The vehicle continued to accelerate, traveling at approximately 40 MPH in a posted 25 MPH zone. The vehicle then turned onto E/B 1st Street and back onto S/B Monterey Blvd. making an abrupt turn onto W/B 1st Ct. pulling to the curb with its driving lights off. I initiated a traffic stop on the vehicle on 1st Ct. at Monterey Blvd.

Investigation: Upon contact with the driver, identified as [REDACTED] Baham, I smelled a strong odor of an alcoholic beverage coming from her person. I asked Baham if she thinks it's smart to be drinking and driving; she related, "No, I just wanted to get home". I checked Baham's eyes and observed a lack of smooth pursuit, along with an early onset of horizontal gaze nystagmus. (Ref. FST's Page one and two for objective signs symptoms).

I had Baham exit the vehicle and asked her some preliminary DUI investigation questions. During my questioning, I explained that she almost rear ended my patrol vehicle; Baham related "I saw that?we were having an argument" "He (Passenger) yelled at me right after that happened". I asked her why she pulled over prior to me initiating the traffic stop; she related "I knew you were behind me and going to pull me over". I explained and demonstrated a set of standard field sobriety tests and had her perform the tests (Ref. Page two). Due to Baham's driving pattern, statements, and her performance during the field sobriety tests, I formed the opinion that her physical and mental abilities were so impaired that she could no longer drive a motor vehicle with the same caution as a sober person, a violation of 23152(a) CVC.

During a search of the vehicle, an open 24oz can of beer (Bud Light) was located on the floorboard behind the driver's seat. The can was up right and not supported by any other item. The can was cold to the touch and had an odor of an alcoholic beverage/beer. Baham admitted knowledge of the beer and claimed it was hers.

Booking: Baham was taken into custody and transported to the H.B.P.D. At the station, I read her the Chemical Test Admonition per, 23612 CVC. Baham chose to take a breath test (Ref. Signed 23612 form). A breath test was obtained with results .13 and .14 BAC at approximately 0215 hours (Ref. Attached results). Baham was advised per 23614 CVC of further chemical tests. She refused her rights to any further chemical tests. Baham was booked into the H.B.P.D. for Driving Under the Influence, 23152(a/b) CVC, without further incident.

Arrest: On 12/7/07 at approximately 0116 hours, [REDACTED] Menold (DOB [REDACTED]) was arrested from the 2600 Blk of Hermosa Avenue for DUI - 23152(a) CVC. She was transported and booked into the H.B.P.D., without further incident.

Probable Cause for Stop: On 12/7/07 at approximately 0054 hours, I responded to the 2600 Blk of Hermosa Avenue to assist Sgt. Gaines #134 on a traffic stop. Upon arrival, Sgt. Gaines related while he was driving southbound Hermosa Avenue (2600 Blk) in the #1 lane, he observed a white Toyota Corolla (Lic. [REDACTED]) driving for approximately one block northbound in the southbound lanes of Hermosa Avenue (A violation of 21651(a) CVC), directly into the path of his marked patrol vehicle. Sgt. I had Menold exit the vehicle and asked her some preliminary DUI questions. While talking with her, I smelled a strong odor of an alcoholic beverage coming from her person. I asked Menold if she had been drinking; she related she had three beers. I checked Menold's eyes and observed a lack of smooth pursuit, along with an early onset of horizontal and vertical gaze nystagmus. (Ref. FST's Page one and two for objective signs symptoms). I explained and demonstrated a set of standard field sobriety tests and had her perform the tests (Ref. Page two). Due to Menold's driving pattern, statements, and her performance during the field sobriety tests, I formed the opinion that her physical and mental abilities were so impaired that she could no longer drive a motor vehicle with the same caution as a sober person, a violation of 23152(a) CVC. 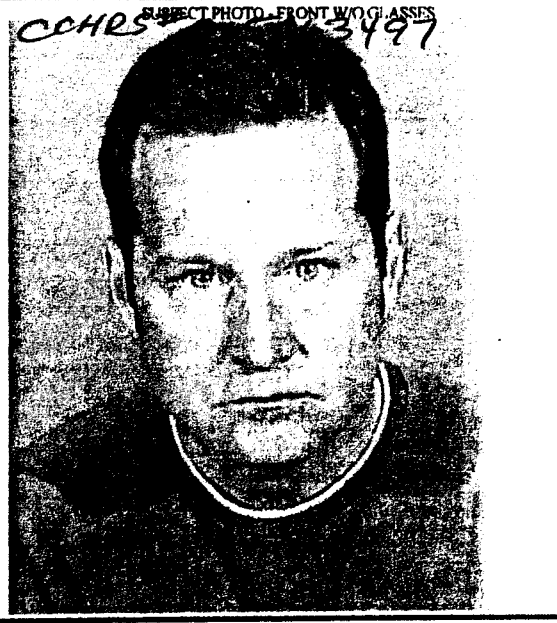
