Narrative

Manhattan Ave. Less than a minute after receiving the money a MBA walked up to him and pointed a silver small semi automatic handgun at him. The suspect pulled the handgun out of the front pouch of his sweatshirt. The suspect said, "Lay down give me the money, give me the money. What you don't think I'll shoot you?". The victim was walking backwards as the suspect pointed the gun at his head and repeated his demands to give him the money and lay down. The victim got backed up against a van in the driveway and saw an opportunity and punched the suspect in the left jaw with his right closed fist. The suspect then struck the victim in the head with the handgun and ran N/B Manhattan Ave and entered a possible red Nissan. The vehicle fled N/B Manhattan Ave. The suspect did not get anything from the victim. He described the suspect as a MBA, 20's, 6-02, shaved head, black hoodie sweatshirt, white basketball shorts with a blue stripe, earring in left ear and a silver semi automatic handgun. The vehicle was described as a new red Nissan possible Versa four door with blue and yellow paper plates. The victim had a small cut with swelling on the left forehead/hairline. He denied medical attention.

W1 (C) who was standing within few feet of the victim stated essentially the same as the victim.

W2 who was also standing within few feet of the victim, also stated essentially the same as V1 and W2. She added that she saw the MBA walking S/B Manhattan Ave as she paid V1. He walked past all of them went approximately one house past there location and walked back towards them. She stated she felt very uncomfortable by his presence. She then saw him approach V1 and point the silver handgun at V1.

An immediate area check of the city and borders was negative.
