Narrative

On 04/10/08 at approximately 2231 hours I responded to [REDACTED] Hermosa Ave regarding a report of a 211 PC - Robbery, which had just occurred. I arrived and contacted the victim [REDACTED] who told me the following.

On 04/10/08 at approximately 2225 hours B [REDACTED] was walking south on the west sidewalk of Hermosa Ave. B [REDACTED] was carrying a large canvas bag, and her purse. As B [REDACTED] was approaching 22nd St., S-1 approached her from in between some vehicles, which were parked on Hermosa Ave. S-1 pointed a gun at B [REDACTED] and stated, "give me your purse or I'll kill you". S-1 grabbed B [REDACTED]'s purse and bag and attempted to pull it away from her. B [REDACTED] and S-1 struggled for property. S-1 was able to take the property from B [REDACTED]. S-1 ran west to the cement median. S-1 told B [REDACTED] not to look at him or he would shoot her. B [REDACTED] lost sight of S-1 once he reached the median.

B [REDACTED] got in to a taxi cab, and got a ride to the North End Bar ([REDACTED] Hermosa Ave) where she called the police.

Officers searched the area for S-1 with negative results. B [REDACTED] stated that she could identify S-1 if seen again.
