Narrative

On 04/10/08 at approximately 2231 hours I responded to Hermosa Ave regarding a report of a 211 PC - Robbery, which had just occurred. I arrived and contacted the victim who told me the following.

On 04/10/08 at approximately 2225 hours Boss was walking south on the west sidewalk of Hermosa Ave. Boss was carrying a large canvas bag, and her purse. As Boss was approaching 22nd St., S-1 approached her from in between some vehicles, which were parked on Hermosa Ave. S-1 pointed a gun at Boss and stated, "give me your purse or I'll kill you". S-1 grabbed Boss so purse and bag and attempted to pull it away from her. Boss and S-1 struggled for property. S-1 was able to take the property from Boss S-1 ran west to the cement median. S-1 told Boss not to look at him or he would shoot her. Boss lost sight of S-1 once he reached the median.

Begin got in to a taxi cab, and got a ride to the North End Bar (Hermosa Ave) where she called the police.

Officers searched the area for S-1 with negative results. Best stated that she could identify S-1 if seen again.
