COMMENCING JULY 1, 2005 AND ENDING JUNE 30, 2006.

WHEREAS, the City Council of the City of Hermosa Beach, California, proposes to
renew the existing assessment district designated as "Hermosa Beach Landscaping and Street
Lighting District 2004-2005" pursuant to the "Landscaping and Lighting Act of 1972", being

## NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** That the City Council hereby redesignates the existing Hermosa Beach Landscaping and Street Lighting District 2004-2005 as the Hermosa Beach Landscaping and Street Lighting District 2005-2006.

**SECTION 2.** That the Director of Public Works is hereby ordered to prepare and file a report in accordance with Article 4 of Chapter 1 of the "Landscaping and Lighting Act of 1972", being Division 15, Part 2 of the Streets and Highways Code of the State of California, for the maintenance and operation of streets and sidewalks within the assessment district,

1	including the operation, maintenance and servicing of landscaping, lighting and appurtenant
	facilities located in and along such streets and sidewalks, for the Fiscal Year commencing July
2	1, 2005 and ending June 30, 2006 all as set forth in this resolution.
3	<b>SECTION 3.</b> That a certified copy of this resolution be presented to the Director of
4	Public Works for his/her information and guidance.
5	<b>SECTION 4</b> . That the City Clerk shall certify to the passage and adoption of this
6	Resolution; shall cause the same to be entered among the original resolutions of said City; and
7	shall make a minute of the passage and adoption thereof in the records of the proceeding of the
8	City Council of said City in the minutes of the meeting at which the same is passed and adopted
