A RESOLUTION OF THE CITY OF HERMOSA BEACH, CALIFORNIA, AMENDING RESOLUTION 90-5422 (MASTER FEE RESOLUTION) TO ADD NEW FEES AND UPDATE EXISTING FEES TO RECOVER COSTS OF PROVIDING THE **SERVICE**

WHEREAS, pursuant to Hermosa Beach Municipal Code 2.64.010, it is the intent of the City Council to require the ascertainment and recovery of costs reasonably borne from fees and charges levied in providing City products or services; and

WHEREAS, costs of providing City services have been determined by updating the user fee study and certain miscellaneous fees;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, **DOES RESOLVE AS FOLLOWS:**

Section 1. That the City Council hereby accepts the fees as contained in the user fee study and finds that the fees, as set forth in the study, are justified and do not exceed the cost of providing the services.

Section 2. That resolution 90-5422, Schedules 1 (except Sewer Connection Fee which was approved on 8/13/05), 2, 3 (except Paramedic Response/Transport which was approved on 8/13/05) and 5, are hereby amended to include fees shown in the attached Schedules 1-3 and 5 as "Recommended Fee". (Building and Planning schedules were combined into one Community Development schedule, resulting in one less schedule)

Section 3. That fees in this resolution shall take effect October 1, 2005, except for fees on Schedule 1 – Community Development, and certain fees marked with an asterisk on the attached Schedule 2 – Public Works, all of which are development-related fees and take effect no earlier than 60 days after adoption, pursuant to Government Code Section 66017 (a).
