Secti	on 3. That fees in this resolution shall take effect September 1, 2005, except for fees on		
Schedule 1 – Community Development, and certain fees marked with an asterisk on the attached			
Schedule 2 – Public Works, all of which are development-related fees and take effect 60 days			
after adoption, pursuant to Government Code Section 66017 (a). Schedule 1 – Community			
Development fees and the two fees marked with an asterisk on the attached Schedule 2 – Public			
Works shall take effect on November 1, 2005.
