



The results of the election canvass show Michael Keegan, Howard Fishman and J.R. Reviczky elected as Members of the City Council, and Measure E (proposed ordinance regarding the City's beach and greenbelt) as failed.

RESOLUTION NO. 05-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD TUESDAY, NOVEMBER 8, 2005, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Hermosa Beach, California, on Tuesday, November 8, 2005, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed; and in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 05-6403 adopted June 28, 2005, and Resolution No. 05-6412, adopted July 26, 2005, the County Election Department canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That there were six (6) voting precincts established in the City for the purpose of holding said election.

That the whole number of ballots cast in the precincts except absent voter ballots was 4,404, and the whole number of absent voter ballots cast in the City was 1,777, making a total of 6,181 ballots cast in the City.

SECTION 2. That the General Municipal Election was held for the election of certain officers and for submitting to the voters one measure.

13 That the measure (Measure E) voted upon at the election is as follows:

14 Shall an ordinance be adopted adding the beach to the Restricted Open 15 Space (O-S-1) zone and prohibiting any improvements in the O-S-1 16 zone except for landscaping, irrigation, erosion control and 17 replacement or repair of existing improvements within their existing 18 footprint?	19 YES

21 **SECTION 3.** That the number of votes given at each precinct and the number
22 of votes given in the City to each of the persons above named for the respective offices for
23 which the persons were candidates and for and against the measure were as listed in the attached
24 Exhibit "A."

25 **SECTION 4.** That the City Council does declare and determine that:

- 26 - **Michael Keegan** was elected as Member of the City Council for the full term of four (4) years;
27 - **Howard L. Fishman** was elected as Member of the City Council for the full term of four (4)
28 years; and
- **J.R. Reviczky** was elected as Member of the City Council for the full term of (4) four years.

1 That as a result of the election, a majority of the voters voting on Measure E,
2 relating to the City's beach and greenbelt, did not vote in favor of it, and the measures was not
3 carried and shall not be deemed adopted and ratified.

4 **SECTION 5.** That the City Clerk shall enter on the records of the City Council
5 of the City a statement of the result of the election, showing: (a) the whole number of ballots
6 cast in the City; (b) the names of the persons voted for; (c) for what office each person was
7 voted for; (d) the measure voted upon; (e) the number of votes given at each precinct to each
8 person, and for and against the measure; and (f) the total number of votes given to each person,
9 and for and against the measure.

10 **SECTION 6.** That the City Clerk shall immediately make and deliver to each of
11 the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that
12 the City Clerk shall also administer to each person elected the Oath of Office prescribed in the
13 Constitution of the State of California and shall have them subscribe to it and file it in the office
14 of the City Clerk. Each and all of the persons so elected shall then be inducted into the
15 respective office to which they have been elected.

16 **SECTION 7.** That the City Clerk shall certify to the passage and adoption of
17 this resolution and enter it into the book of original Resolutions.
