A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HERMOSA BEACH, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD TUESDAY, NOVEMBER 8, 2005, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW
WHEREAS, a General Municipal Election was held and conducted in the City
of Hermosa Beach, California, on Tuesday, November 8, 2005, as required by law; and

That the whole number of ballots cast in the precincts except absent voter ballots was 4,404, and the whole number of absent voter ballots cast in the City was 1,777, making a total of 6,181 ballots cast in the City.

SECTION 2. That the General Municipal Election was held for the election of certain officers and for submitting to the voters one measure.
