Background:

On May 9, 2006, City Council approved the award of the construction contract for Project No. 05-643 Pier Concrete Deck Treatment to KC Industries, Inc. The work included the removal of all existing coatings by shot blasting, various concrete and joint repairs, and the application of "Surtreat" to protect the concrete and steel reinforcement from corrosion

The project was constructed according to the plans, specifications and change orders prepared by Staff. Therefore, Staff recommends acceptance of the work as complete. The remaining punch list items have all been completed.
