BEACH VOLLEYBALL COURT INSTALLATION

Recommendation

Staff recommends that Commission consider resident request to install two (2) beach volleyball courts at Lynden Street and the Strand.

Background

The Community Resources Department received a letter of request and application form from Tim Henning (Attachment A) dated April 13, 2004. Mr. Henning has requested installation of two (2) beach volleyball courts south of Lynden Street. The purpose of Mr. Henning's request is to accommodate the increasing number of volleyball players at the south end of the Strand.

Analysis

In coordination with the Departments of Public Works and Community Resources the Parks and Recreation Commission instituted a Beach Volleyball Court Policy and Application form in 1997 (Attachment B). The policy includes a Court Specification Sheet that stipulates there shall be no more than two (2) volleyball courts per Strand block, with the exception of courts 'grand fathered' in at the time of policy development. Installation of courts south of Lynden Street would not violate this policy.

Another option for players is to utilize temporary volleyball courts. The regulation of two (2) courts per Strand block also applies to temporary courts. Pursuant to municipal code, all beach equipment, which includes temporary nets, must be removed from the beach during the nighttime.

Alternatives:

- A. Install two (2) new beach volleyball courts
- B. Install one (1) new beach volleyball court
- C. Deny request to install new beach volleyball courts
